2 Announcements from the Chair

7 To consider matters relating to the festivities

Cllr Eastwood informed the Committee that she had secured a deal to get consumables from McColl's on 'sale and return'. She said that everything was going as planned for the 13th December at 4pm.

After some deliberation, it was decided that the Parish Council was not in a position to provide the help requested, but the Committee unanimously resolved to help the SCBPP as much as possible in finding a viable solution.
