

CUMBERLAND COUNCIL (A5086 ROWRAH ROAD AND PARKSIDE ROAD AND A595 WHICHAM VALLEY) (TEMPORARY TRAFFIC REGULATION) ORDER 2023

NOTICE IS HEREBY GIVEN that to enable Cumberland Council Highways Service to carry out highway works (“the Works”), Cumberland Council intends to make an Order the effect of which is to prohibit any vehicle from proceeding along the lengths of road specified in the attached Schedule.

Suitable diversion routes will be indicated on site by the display of relevant traffic signs as and when the temporary closures are in force. Phased works will not necessarily be done in numerical order.

Cumberland Council will ensure that local residents and the general public are informed of which roads are to be closed and when, nearer the time. A way for pedestrians and dismounted cyclists will be maintained at all times.

Nothing in the Order to which this notice relates shall:

1. Apply to emergency service vehicles, or vehicles being used by statutory undertakers in the performance of their duties; and
2. Apply to anything done with the permission or at the direction of a police constable in uniform; and
3. Have the effect of preventing at any time access for pedestrians to any premises situated on or adjacent to the roads, or to any other premises accessible for pedestrians from, and only from the road; and
4. Apply to vehicles being used in connection with the Works.

The Order will come into operation on 8 January 2024 and may continue in force for a maximum duration of eighteen months. However, please note that it is anticipated that the restrictions will only be required within the 3 month period from 8 January 2024, and only as and when the relevant traffic signs are displayed.

SCHEDULE
EXTENT OF RESTRICTIONS AND ALTERNATIVE ROUTES

1. A5086 Rowrah Road, Rowrah - Approx. duration 7 weeks (Ref: TTROC/9352)

From its junction with the C2054 to its junction with Pasture Road.

Alternative Route: via the unrestricted sections of Rowrah Road, Peppercoats Brow, A66, A595, Hensingham Bypass, Egremont Road, A5086, Main Street, Trumpet Terrace Trumpet Road, Frizington Road, Main Street and Arlecdon Parks Road.

2. A5086 Parkside Road, Cleator Moor - Approx. duration 5 weeks (Ref: TTROC/9356)

From its junction with Park Street extending in a south westerly direction for approx. 1.15km

Alternative Route: via Frizington Road, Main Street, Arlecdon Parks Road, Rowrah Road, Peppercoats Brow, A66, A595, Hensingham Bypass, Egremont Road, A5086, Main Street, Trumpet Terrace and Trumpet Road.

3. A595 Whicham Valley - Approx. duration 6 weeks (Ref: TTROC/9426)

From its south western junction with the A5093 to its north eastern junction with the A5093

Alternative Route: via the A5093.
